LICENSE AGREEMENT FOR USE OF REAL PROPERTY

THIS LICENSE AGREEMENT FOR USE OF REAL PROPERTY ("Agreement") is made and entered into effective as of the 2nd day of March, 2020, by and between LAKE CENTRAL SCHOOL CORPORATION, an Indiana public school corporation, 8260 Wicker Avenue, St. John, Indiana 46373 ("Licensor") and the TOWN OF DYER, INDIANA, an Indiana municipal corporation, One Town Square, Dyer, Indiana 46311 ("Licensee").

WHEREAS, Licensor, is the owner of the real estate comprising the Kahler Middle School campus located at 600 Joliet Street, Dyer, Indiana ("Licensor Parcel"), as depicted on Exhibit A attached hereto; and

WHEREAS, Licensee, through its Parks and Recreation Department coordinates outdoor recreational activities for the residents of the Town; and

WHEREAS, Licensee has requested access to and use of the Licensor Parcel, for the sole purpose of installation and operation of, and related maintenance for, a Thor Guard lightening prediction receiving unit ("lightening unit") on a light pole located on Licensor's Parcel as depicted on <u>Exhibit B</u> attached hereto ("project"), which will alert, with sound and light to warn of lightening or worsening weather conditions, those residing and/or engaged in outdoor activities on or near the Licensor Parcel to take shelter; and

WHEREAS, Licensor is amendable to such use to enhance public safety, subject to the terms and conditions set forth herein.

NOW THEREFORE, in consideration of the following mutual covenants and other good and valuable consideration, the sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Subject to Licensee's receipt of all required approvals and permits from applicable agencies and bodies for the contemplated project, Licensor hereby grants to Licensee a revocable license to enter upon and traverse across the Licensor Parcel and use the light pole identified in <u>Exhibit B</u> for the sole purpose of installing, operating and maintaining the lightening unit for a period of time commencing on March 23, 2020 and ending on March 22, 2025 ("License Period"). Said License may be revoked upon violation of the terms hereof by Licensee or Licensee's agents, contractors and invitees at Licensor's sole discretion by providing written notice of revocation to Licensee.

2. Licensee's use of the Licensor Parcel and designated light pole shall be limited as follows:

a. Licensee shall obtain advance approval from Licensor's designated representative to schedule dates and times for each event requiring access for the uses specified herein.

b. Access and use shall be limited to Licensee and its authorized agents, contractors or invitees for the uses specified herein including installation of the lightening unit on the designated light pole, periodic access to install and remove solar batteries and to perform such other maintenance necessary to the operation of the unit.

c. Approved access for such limited purposes shall be between the hours of 7:00 a.m. and 4:00 p.m. Monday – Friday as approved in advance by Licensor's designated representative, or as otherwise approved in advance by Licensor's designated representative and in any event, shall not interfere with school traffic or events.

d. Licensee shall take all steps necessary and appropriate to assure that the lightening unit, and all components, are installed securely and in such a manner to withstand wind and weather conditions and not cause damage or injury to Licensor's students, staff, and other invitees or its or their property, and further so as not to interfere with the functioning of and Licensor's access to its light system installed on the designated pole.

e. Neither Licensee nor its authorized agents, contractors or invitees shall allow overnight parking of any equipment, trailers or motorized vehicles on the Licensor Parcel.

f. In the event Licensor elects to replace the designated light pole during the License Period, upon Licensor's request, Licensee, at its sole expense, shall remove or cause to be removed the lightening unit and will thereafter be allowed to reinstall the same on the replacement pole.

g. Prior to expiration of the License Period, Licensee, at its sole expense, shall remove or cause to be removed from the designated light pole, the lightening unit and any related apparatus. As applicable, Licensee shall further restore and repair the pole and the Licensor Parcel to the condition in which it existed prior to Licensee's use hereunder.

h. Any cost, expense or liability connected with or in any manner incident to the granting, exercise, enjoyment or relinquishment of this license shall be assumed and discharged by the Licensee.

i. Licensee's use hereunder shall be consistent with all applicable governing laws, regulations, and ordinances.

3. Licensee and its agents, contractors or invitees shall maintain adequate insurance coverage, including liability, casualty, and worker's compensation insurance for the installation, operation and maintenance of the lightening unit and access to and related use of the Licensor Parcel contemplated hereunder. In addition, throughout the term of the License Period Licensee shall maintain, and prior to commencement of the License Period Licensee shall provide to Licensor a certificate of commercial general liability insurance with at least a \$1,000,000 single combined limit covering access to and use of Licensor's Parcel as herein provided naming Licensor as additional insured.

4. Licensee shall indemnify, defend (using counsel selected by Licensor) and hold Licensor and its successors in interest and assigns, harmless from and against any liability, damages, expenses, costs, injuries and reasonable attorney fees sustained or incurred by Licensor and its officers and employees, resulting from or by virtue of any act or omission by Licensee or its agents, contractors, or invitees from their access and use of Licensor's parcel. Licensee's obligations under this section survive the conclusion of the License Period.

5. For purposes of this Agreement, Licensor's designated representative shall be Licensor's Director of Construction and Facilities.

6. This Agreement (including all Exhibits hereto) contains the entire agreement between the parties respecting the matters herein set forth and supersedes all prior agreements between the parties hereto respecting such matters. This Agreement may be executed in counterparts, each of which may be deemed to be an original agreement but all of which together shall constitute one and the same instrument. The exchange of copies of this Agreement and of signature pages by electronic mail or facsimile transmission shall constitute effective execution and delivery as to the parties and may be used in lieu of the original for all purposes.


