Legislative Update 4.5.21

- Significant language regarding voucher expansion has been moved to the budget bill
- There is a price so this is not completely inappropriate however it will all but assure the approval
 of most elected officials because the budget must be passed
- Providing a large portion of the new money earmarked for k-12 education to private and home school students in times where public school mandates continue to grow is not fair
- The general assembly should stop using the term "choice" to describe the way they are distributing the new money
- The trickiest students to educate, along with anyone who does not present as conforming to
 private school expectations, (behavior challenges, developmentally delayed, alternate dressers
 or members of LGBTQ population) are not given a "choice"
- The increases to salary "restrictions" to \$145,00 is simply a defacto tax cut for wealthy families who already "choose" private schools in Indiana
- It appears that until elected officials are held accountable at election time, the trend to fully funding private schools without most of the rules and mandated placed on public schools will continue

Update on ESSER (CARES Act) and ESSER II Expenditures

I will be giving the School Board an update on the costs we have incurred over the past 12 months and costs we will incur in the future related to the COVID-19 pandemic.

Review of COVID-19 Pandemic Expenditures

- Expenditures incurred after March 13, 2020 qualify as allowable expenditures from the ESSER (CARES Act) and ESSER II federal grants
- Lake Central Allocations:
 - ESSER I = \$620,599 (\$575,780 to LCSC; \$44,819 shared w/ parochial schools)
 - o ESSER II = \$2,591,578
- Pandemic Related Expenditures so far:
 - o PPE (masks, thermometers, sanitizer, cleaning supplies, Plexiglass, etc) ~ \$375,000
 - o Six additional elementary teachers to do E-Learning ~ \$600,000
 - Ten additional custodians ~ \$500,000 (annually)
 - o Shortfall in Food Service Fund due to loss of revenue ~ \$500,000
 - Technology to implement E-Learning platform (classroom cameras, cabling, Google Meet, curriculum software, etc) ~ \$60,000
 - An additional \$600,000 was spent on Chromebooks and laptops, but those were purchased through the Common School Fund Loan
- Upcoming Expenses:
 - o Expanded Summer School
 - Additional Instructional Support to address learning loss in 2021/2022 SY
 - Additional counselors / social workers to address socialization issues
 - HVAC upgrades
- Since this is one-time money, we cannot use these funds to give contractual or wage rate pay
 increases to staff; those would be permanent costs that could not be sustainable after the grant
 ends.
- Will need to be careful about adding staff or programs for the same reason.
