Howard Marshall: Last evening, I watched the television program 60 Minutes. They had a segment that was talking about AI - Artificial intelligence. They were talking about some of the companies involved and what they're projecting and what they plan on doing for the future. Jennifer Medlen: I just want to address what Mrs. Schrantz brought up, that I appreciate you coming to the meeting and speaking to us and, I for one will do what I can to contact legislators in that fashion as well.

Janice Malchow: Hearing the tidbits of conversation tonight it makes me very sad, where we're going in this world, and where we possibly could be going. Larry, your comment earlier about students and their behavior, and it just reminds me of the days when you just have to regroup and say we are going to keep control. And there's all this stuff that's out there, this tik tok about this teacher being attacked by the student because she took one of his computer devices. You know, there's all this stuff that's being fed to our students and it's so sad, it just really makes me sad, and then the comment that you make about labeling our students and where is that going to go. And, some of us have had some conversation, this may not be politically correct, but quite honestly, I don't care, because I don't care right now, but what's interesting is that all of our Representatives, all of our Representatives went to private schools. None of them went to public school. But there they sit and make decisions based on rules and regulations for public school. And, I know Nicole and I have talked about this quite a bit, and it's probably time that we as a board get together and get a unified approach to this. I know we mentioned it before, and I just don't like whats coming out of either the state level or the federal level. So, Nicole if maybe we get together sometime this week and maybe Jennifer, I know she has an interest in that also, we can put together some ideas. Can we do that legally? Three of us? Well, then we can meet separately.

Cindy Sues: Thank you Mrs. Schrantz for coming out. I have to ask you, was that one of your children in the play the other night ... High School Musical? Okay, wonderful. That brings me to that. I went to the High School Musical and it was fabulous! So if you missed it, I'm sorry, but great job to all that were involved. And, I know Dr. Veracco said he went back on his word about the e-learning but it turned out okay for my child. We had no hiccups, so thank you for all of the messages that went out from the high school and Mrs. Castaneda (I only have a high schooler) but I thought it went really well.

Dr. Veracco: Yes, I think it did too, just from observing my older son do the work, and have him the night before say to me, what do you mean it's not asynchronous? He said, they're going to make us do all the work then and this isn't as good a day (off). So, we'd still rather be in person, and so I'll state that, but we've come miles from a couple years ago, and so I can say that what I observed was certainly better than when a sub is in a classroom because my son's teachers were engaging with him and it was good to hear. So thank you for noticing, Mrs. Sues.


